We discussed this with Word is that employees are not to respond to surveys that have not been approved by the Washington Office....this applies whether they respond in the office or from home, since the survey is directed specifically at government employees and they can't realistically respond outside of their official capacity. Awaiting Director's approval also protects the employee from any appearance of conflict.



The purpose of this memorandum is to ensure that employees receive notification that the only surveys they are authorized to respond to during duty hours are ones that have been authorized by the Service, the Department, or other Federal agencies. Employees can determine whether a survey is authorized by the Service by looking for the signature of or e-mail from an appropriate

Service official transmitting the survey. In the case of a survey that is from the Department or another Federal agency, employees must receive written notification from the Director of the upcoming survey before completing it. Absent such evidence, employees must not respond to surveys during their duty hours. Please contact your servicing personnel office if you have any questions or need additional information.

Recently, PEER sent out a survey to ES biologists nationwide. These surveys were sent to office addresses and at a time to coincide with an official survey being conducted by the Service/DOI; thus, making it possible for an employee to think it was the official DOI/FWS survey.

I forwarded a query up the line, and while there is still much bureaucratic discussion going on, everyone agrees such surveys are no official and as such should not be completed by employees: particularly when received at the office or via official email.

if you have already filled out, the survey police will not be knocking down your door. However, if you have not, the recommendation is you simply throw it away.

There was something put out from DOI/FWS several months ago about this matter, however, apparently it never made it into the form of an official policy. Based on the discussions I have "heard" this will likely be corrected shortly.
